Into the main vessel add:					
Purified Water	Start the mixer on a moderate speed.				
Glycerin BP	Mix until dissolved.				
	Turn the mixer speed up to fast speed.				
etpro Pullulan Mix until dissolved. (This could take a little while)					
Once the Pullulan has dissolved and	no lumps remain add:				
Keltrol RD					
Glucomannan 95%	Once the powders have dispersed reduce the mixer speed to moderate\slow.				
Sisterna SP70-C					
Sisterna SP30-C	Commence heating the main vessel to 75-80C.				
Into the premix vessel add:					
Floraesters [®] 60					
Floraesters [®] 70					
Surfac Stearic Acid					
Palmitic Acid 800508					
Corum 5041					
Floviva Shea Butter					
When both vessels are at 75C-8	0C add the premix vessel into the main vessel.				
Mix for 5 minutes at a moderate	e fast speed.				
After 5 minutes reduce the mixe	er speed to a slow speed and add:				
AMP-ULTRA™ PC 2000					
Commence cooling to 35C.					
When the bulk is 40C or below,	into a suitable premix vessel add:				
Purified Water					
Geoguard Ultra	Mix until dissolved				
Add the premix to the main ves	sel.				
Continue to cool to 35C					
When the product is at 35C pac	k into suitable packaging
