# **Method of Manufacture**

Into the main vessel add:				
Purified Water (1)	Start the mixer on a moderate fast speed.			
FD&C Yellow 6	Mix until dissolved.			
Disodium EDTA	Mix until dissolved.			
Organic Glycerin	Mix until dispersed.			
Aristoflex® AVC	Add slowly avoiding clumping.			
	Increase mixer speed (IKA RW 20 1200RPM) Mix until clear and homogenous.			
Euxyl PE9010	Mix until dispersed. Turn down mixer speed to moderate.			
	Commence heating to 75C-80C.			

# Into the premix vessel add:

Syncrowax HRC

#### Emulpharma® IXL

Crodamol IPM

Saboderm TCC

Drakeol 35 MIN OIL USP

Tegosoft® CO

Saboderm AB

Parsol MCX

Parsol 1789

Parsol 340

Surfac CS

BC Dimethicone 350cs Commence heating the premix vessel to 75C-80C

When both vessels are at 75C-80C add the premix vessel into the main vessel.

# Homogenize for 5 minutes.

After 5 minutes switch off the homogeniser.

Commence cooling to 23C, use a paddle or gate stirrer at a slow speed.

Into a suitable sized premix vessel add:

**Alpine Rose Active** 

PhytoCellTec™ Argan Mix until all the PhytoCellTec™ Argan has dissolved

When the bulk is at 40C or below add the premix into the main vessel. Mix until homogenous.

Cool to 23C and check the product specifications.
